

## Westfund Health Insurance

### 6 Weeks Free Retention Offer

1. These Terms and Conditions apply to the “6 Weeks Free” Retention Offer (“Offer”). By participating, you agree to be bound by these Terms and Conditions.
2. The Offer is provided by Westfund Limited ABN 55 002 080 864 of 59 Read Ave, Lithgow NSW 2790 (“Westfund”).

#### **The Offer**

3. The Offer runs from 12.01am (AEDT) 9 March 2026 to 11.59pm (AEST) 30 September 2026 (Offer Period). Retentions made outside this period are not eligible.
4. The Offer applies to eligible products (Eligible Products). Eligible Products include all Combined Hospital and Extras cover or Hospital Only policies offered by the Promoter, except the following exclusions (Ineligible Products):
  - a. Gold Ultimate Hospital only policies
  - b. Ambulance only policies
  - c. Athlete policies
  - d. Extras-only policies
  - e. Corporate policies
  - f. Overseas policies
5. The Offer consists of a credit equivalent of 6 weeks of premium applied to an Eligible Product, subject to the eligibility and fulfilment conditions set out in these Terms and Conditions.
6. Limit of one Offer per membership per lifetime.

## **Terms and Conditions for the Offer**

7. To receive the Offer, Eligible Members must:

- a. be considering cancelling their membership with Westfund;
- b. have held continuous, financial cover with Westfund for at least 2 consecutive years, calculated from the date their Westfund membership commenced;
- c. have held any Hospital Only or Combined Hospital & Extras cover (excluding Athlete, Overseas or Corporate policies) for at least 1 year prior to the Offer;
- d. have any prior promotional or retention offers expired or concluded more than 2 years before the date this offer is applied
- e. not be an employee of the Promoter;
- f. not be transitioning to their own Westfund cover (for example, dependants leaving a family policy, or a partner taking out their own policy); and
- g. maintain continuous, financial eligible cover for the duration of 90 day review period.

8. Westfund representatives must apply the promotion code SIXWF26 for the member to be eligible for Offer.

9. An Eligible Member may change their level of cover during the fulfilment period

of the offer. And weeks' free cover applied will reflect the level of eligible cover held at the time the benefit is applied.

## **Distribution of Offer**

10. Eligible Members will receive the Offer as follows:

### **6 Weeks Free**

9.1 The 6 weeks' free cover will be applied after the member has maintained

continuous, financial cover on an Eligible Product for 90 consecutive days from when the promotion code is applied to the membership.

9.2 The benefit is applied by advancing the paid-to date by 6 weeks, meaning the following 6 weeks of cover will be treated as paid. Please allow up to 30 days after this period for the benefit to be applied.

### **General Conditions**

11. The Offer cannot be combined with other promotions unless stated.

12. Standard yearly limits, waiting periods, benefit claiming restriction, policy and fund rules apply.

13. If a member does not satisfy these Terms and Conditions, Westfund may, acting reasonably, elect not to award the Offer.

14. Proof of eligibility may be requested.

15. The Offer is not redeemable for cash and is not exchangeable or transferable.

16. The Promoter reserves the right to amend or withdraw the Offer at any time.

17. An otherwise valid membership will not be rendered invalid due to printing errors or other quality control matters.

18. The Promoter accepts no responsibility for late joins, or processing delays that may result in ineligibility for the Offer.
